Terms and conditions

1. Earnest Money of Rs. 50,000/- in the form of DD/Deposit-at- call drawn in favour of the Inspector General of Police (Adm), Manipur, Imphal and the following clearance Certificates be submitted along with the Tender so as to reach PHQ upto 1 p.m. of 14/12/2009
 - a) Valid VAT clearance certificate with the TIN Number (duly attested).
 - b) Valid VAT registration certificate (duly attested).
 - c) Valid Central Sales Tax registration Certificate (duly attested).
2. If the Tenderer happens to be any type of firm/association or any organized body only such person(s) who are legally competent to sign should sign the concerned papers such as the Bids/Tenders, Contact Deed etc. on behalf of the firm. Such person(s) shall furnish an undertaking making him and such other functionary as also the firm responsible jointly and individually on all connected matters. Failure to do will result in right to rejection of offer without any notice and compensation.
3. The rates should be quoted both in figure and words mentioning the taxes and other charges. If any Tender is withdrawn before due date the earnest money will be forfeited and such Tender will be debarred from tendering for any supply/contract in the Department for a period of 2 (two) years. Similarly the earnest money of successful Tenderer, who refuses to undertake the contract after final selection by the competent authority will be forfeited besides being debarred from tendering for supply of any item to the Department for the next 2 (two) years.
4. Only single Sample of each item should be submitted along with the tender bid. The successful tenderer will be require to furnish security deposit @10% of the total value of the items to be supplied for the fulfillment of his/her contract in the form of DD/deposite-at-call drawn in favour of the Inspector General of Police (Adm), Manipur, Imphal and sign a Contract Deed with Department before the commence of work and must abide by the Terms and Conditions laid down in the Tender Notice and Contract Deed.
5. The successful Bidder/supplier shall ensure to supply the items as per time schedule mentioned in the Supply order. The item so supplied shall be of same quality/specification as those of the sample submitted in response to this Tender.
6. In the event of rejection, failing, declining, neglecting or delaying to company with any demand or requisition, the Department will be at liberty (without prejudice to any other remedy the Department may resort to on account of any claim for compliance and failure to abide by the supply schedule) to cancel the Tender.

7. Local sale Tax / VAT will be deducted at source.
8. Preference will be given to those suppliers who can supply without insisting on any advance payment.
9. Tenders which do not fulfill all or any of the above conditions or incomplete in any respect are liable to be summarily rejected. Canvassing in any form in connection with the Tender is prohibited and the Tenders submitted by the Tenderers who resort to canvassing/bringing under pressure of any kind are liable to be rejected without any notice and compensation.
10. The Police Department reserves the right to enhance or reduce the amount of security deposit at any time till the placing of supply orders on the successful bidder/Tenderer.
11. Further, the Police Department also reserves the right to terminate any or all Tenders without assigning any reason, whatsoever by giving 15 days notice in writing and is also bound to accept the lowest tender without assigning any reasons therefore.
12. In case of dispute on any matter arising out of the contract, decision of the arbitrator appointed by the Government of Manipur will be binding on both parties.
13. The Police Department reserves the right to fix the quantity of each items to be procured after finalization of the rates and firms by the government as per the availability of fund
14. Any further information required in this regard may be obtained on application on any day from Inspector General of Police (Adm), Imphal, Manipur.
